# 2020 Distinguished Faculty Lecturer Award

**Dr. Valerie Hegstrom**, professor in the BYU Department of Spanish & Portuguese, provided the Phi Kappa Phi Distinguished Faculty

Lecture on Thursday, November 5, 2020 entitled *The Love of Learning: Early Modern Iberian Women Writers as Advocates for Women's Education* 

In the Middle Ages and the Early



Modern period, many societal forces limited women's access to education. Debates circulated about whether women were capable of learning and whether it was appropriate to educate them. Not surprisingly, women writers of the time held strong opinions about their own learning, about what kinds of knowledge women should be taught, and about women's capabilities to learn and contribute. Dr. Hegstrom described what early women writers from Spain and Portugal had to say about learning and related it to problems we face today as we strive to educate women and men.

Dr. Valerie Hegstrom received her PhD from the University of Kansas. Her research focuses on the recovery of literary works by Early Modern women who wrote in Spanish and Portuguese. She coordinates the BYU Global Women's Studies Program and serves as faculty advisor to the Women's Studies Honor Society.

## **BillionGraves Service Project**

Across the world, gravestones are deteriorating, and erosion is erasing precious details of our ancestors' lives. Volunteers have uploaded photos of these gravestones to BillionGraves to preserve them. During November and December 2020, BYU Phi Kappa Phi members transcribed the information on some of these



photos (similar to FamilySearch Indexing) to make it easier for people to discover their ancestors.

This project continued over a three week period, ending on December 7, 2020. Those who completed at least 15 transcriptions were entered into a drawing to win Cougar Cash, and those who completed at least 30 were entered into a second drawing!

#### **Initiations**

As the 2020 initiation banquet was canceled due to the pandemic, we recognized both the 2020 and 2021 initiates during this online cer-

emony. In total, 162 candidates from 2020 and 167 from 2021 were initiated at the ceremony: 10 faculty members, 54 graduate students, 179 senior students, and 86 junior students.

### **Keynote Address:**

**Brent L. Top**BYU Professor of Church
History & Doctrine

Dr. Brent L. Top of the BYU Department of Church History & Doctrine delivered the keynote address at the 2021 annual initiation ceremony, entitled *Honors, Honorable, and Honoring:* What It Means to Be in the Lord's Honor Society.



In this address, Dr. Top discussed the various meanings of the word *honor*. Dr. Top explained that he was honored to be inducted into the BYU Chapter of Phi Kappa Phi in 1985 as a PhD student in the College of Education. This specific honor represents one of



the meanings of this word, which is *great* achievement. Synonyms include such terms as acclaim, commendation, ac-

colades, or praise. These terms reflect many of the worldly views of honor. A second set of synonyms for honor provides a substantially different view of the meaning of this word. Terms such as obeisance, veneration, reverence, or exaltation provide a nobler, more profound view of honor. Dr. Top invited the new initiates to consider the expectations and stan-

dards required to belong in the Lord's honor society. For the Lord, honor can be defined as *high moral worth*.

Dr. Top explained that President Russell M. Nelson is an example of an individual who exemplifies both types of honor, having accomplished outstanding medical discoveries and advancements, while also devoting his life to living the Lord's standards to encourage high moral worth, both in himself and others. Dr. Top further explained that the word *honorable* has to do with people and actions that are honest, fair, and worthy of respect. A particularly insightful definition of honorable is *to bring honor, credit, and respect to its owner.* Dr. Top compared this definition to the Hebrew word *segullah* that appears in the Hebrew Bible.



Segullah literally means *a peculiar treasure*, signifying that something or someone is a *prized* 

possession or a jewel of great worth. Members of the Lord's honor society are indeed a peculiar treasure, a prized possession, and a pearl of great price. We truly become honorable as we seek to bring honor, credit, and respect to our Heavenly Father and the Lord Jesus Christ.

Lastly, Dr. Top elaborated on the word honoring, which he defined as treating others as valuable, costly, and precious as beloved daughters and sons of God in their own right. Important synonyms for honoring include seeing others through God's eyes, loving, respecting, serving, and forgiving. Dr. Top encouraged all to seek to obtain and maintain membership in the Lord's honor society by having high moral worth, being honorable, and continually honoring, loving, serving, and understanding others.

## 2020 Distinguished Service Award

*Dr. Lawrence Rees*, emeritus professor of the BYU Department of Physics and Astronomy,

received the 2020 Phi Kappa Phi Distinguished Service Award. Larry retired in 2019 after 33 years at the University. For nearly 20 of those years, Larry served on the executive committee of the BYU Chapter of Phi Kappa Phi, holding



positions as chapter president and grants and scholarships coordinator. However, it was as secretary that Larry dedicated most of his time in service to the Chapter, maintaining the website, managing membership responsibilities, and coordinating official chapter communications with members. Larry provided steady and enthusiastic leadership to our chapter and was an ardent champion of the success of our student members.

## 2021 Distinguished Service Award

Connie Lamb, Women's Studies, Anthropol-



ogy, & Middle East Studies Librarian, received the 2021 Phi Kappa Phi Distinguished Service Award. Connie retired in December 2020 after 41 years of service at the University. Connie has served in various positions in the BYU

Chapter of Phi Kappa Phi since 1991, including the special projects officer (precursor to the college contests) from 1991 to 2001, treasurer from 2004 to 2011, and most recently as historian from 2010 to 2020, where she helped to preserve an important history of chapter functions and activities. As a valued member of the chapter's executive committee, Connie provided sound advice and regularly volunteered to help with countless service projects and activities.

#### 2021 Honored Member Award

Dr. Brent L. Top, BYU professor of Church History & Doctrine, received the 2021 Phi

Kappa Phi Honored Member Award. Dr. Top also provided the keynote address at the online initiation ceremony. He received a Bachelors degree in history, Masters degrees in Instructional Media and Ancient Scripture, and a PhD



in Instructional Science and Technology, all from BYU, where he graduated with honors.

As dean of Religious Education, he created the Office of Religious Outreach and the Religious Outreach Council. In that capacity he hosted scores of religious leaders and scholars of religion at BYU. After his term as dean, he was appointed the coordinator of the Office of Religious Outreach and chair of the Religious Outreach Council. He served in those roles until his appointment as holder of the Richard L. Evans Chair of Religious Understanding.

He is member of the Latter-day Saint-Jewish Academic Dialogue group as well as the LDS-Evangelical Dialogue group. He is the author of 20 Latter-day Saint books and numerous articles on doctrinal, historical, educational, and sociological subjects. Professor Top has received the Student Alumni Association's Teacher of the Year Award and the Robert J. Matthews Award for Teaching Excellence in Religious Education at BYU.



## National Award & Grant Recipients

#### Phi Kappa Phi National Fellowship

Each year the national Phi Kappa Phi organization awards fifty-four graduate fellowships of \$8,500 each, six at \$20,000 each, and two at \$35,000 each to members entering the first year of graduate or professional study. Each chapter can choose one nominee to represent the chapter in the fellowship competition.
